- 1. The text on pages 1 and 2 of the diploma is printed and identical in all joint diplomas.
- 2. The information specified in the angle brackets is written or printed according to each case.
- 3. On page 1 of the diploma:
- 3.1 the words "REPUBLIC OF LATVIA" are printed typographically using offset in black colour;
- 3.2 image of Large National Coat of Arms is coloured;
- 3.3 the word "DIPLOMA" is embossed using hot-press technique with a foil in golden colour.
- 4. On page 2 of the diploma:
- 4.1 titles of higher education institutions/colleges and diploma series are printed typographically using offset in black colour;

- 4.2 emblems of higher education institutions/colleges are coloured;
- 4.3 the number of the diploma is printed in letterpress printing;
- 4.4 the placement of higher education institution/college names and emblems may vary depending on their number.
- 5. On page 3 of the diploma:
- 5.1 10 mm from the upper right side, a hologram of single template is printed using hot-press. Diameter of the hologram is 17 mm;
- 5.2 O defence element a hologram showing the Large National Coat of Arms, under which the semi-circular inscription "higher education" is placed, but in the background on the horizontal lines the inscription "Ministry of Education and Science".
- 5.3 indicates the commission or other decision-making body entitled to take a decision on awarding a degree/qualification or degree and qualification under an agreement between the higher education institution and the partner institutions;
- 5.4 the name of the degree/qualification or degree and qualification must be indicated in accordance with the agreement concluded;
- 5.5 if more than two partner institutions are involved in the implementation of the joint study programme, page 2 of the diploma must indicate all partner institutions and page 3 of the diploma must provide space for the signatures of officials of all partner institutions;
- 5.6 the location of the signature positions may vary depending on the number of signatures.
